If the executive officer's employment is terminated on or after January 1, 2004, the option may be exercised for 1/48th of the total option for each full calendar month the executive officer has been employed by NeuroMetrix, Inc. (the "Company") since January 1, 2003.
- This option vests as follows: 2/7th of the option vests on June 5, 2004 and the remainder in 30 equal monthly installments thereafter.
- This option vests as follows: 25% on June 2, 2005 and 1/16th per quarter thereafter.
- In the event the Company completes an initial public offering on or before December 31, 2004 and the offering price per share is greater than \$6.00, then the exercise price per share will be automatically increased to equal the price per share in the offering.
